At the September 11, 2017 School Board Regular meeting of the White Bear Lake Area School Board, the following items were presented and discussed:

- 1. <u>Induction of Student Representatives</u>. We are pleased to welcome our new student representatives for the 2017-18 school year. They are: Ashley Rensted, 12th grade student at South Campus, who will serve as the Student Representative for the 2017-18 school year; and Makena Pratt, 11th grade student at South Campus, who will serve as the Alternate Student Representative for the 2017-18 school year.
- 2. <u>Opening School Report</u>. Members of the Leadership Team highlighted work done this summer and through the final days before school began to help students, staff, and families get off to a good start. District programs and services were highlighted at the meeting.

Assistant Superintendents Tim Wald and Sara Paul presented information about priorities for 2017-18, including: improving instructional practices, expanding college and career opportunities, equity: closing achievement and opportunity gaps, operating levy renewal, strategic planning process, comprehensive facilities planning.
- 5. <u>Opening Enrollment Report</u>. Tim Wald, Assistant Superintendent for Finance and Operations, presented opening school enrollment as of the end of the first week of school.

- 3. Action on Special Work-Study Session on September 19 for the Purpose of Reviewing Strategic Planning Process for 2017-18. The School Board approved the special work-study meeting for September 19 at 7:00 p.m. for the purpose of discussing a strategic planning process with Dr. Cook, Cambrian Group.
- 4. Action on Special Meeting on September 25 at 5:15 p.m. for the Purpose of Certification of 2017 Pay 2018 Proposed Property Tax Levy. The School Board approved the special meeting for September 25, 2017 at 5:15 p.m. for the purpose of certification of 2017 pay 2018 proposed property tax levy.
